PARENTAL AGREEMENT

Academic Year 2026 – 2027

1. A child's enrolment is deemed complete and confirmed only after all required forms and documentation have been signed and submitted, regardless of registration fee payment.
2. Enrolment is only considered complete upon signing and submission of the Financial Agreement.
3. Applicants are required to participate in an entrance assessment and a parents/guardians meeting. Admission decisions will be based on the assessment results and other relevant criteria.
4. Admission may be declined based on academic performance, behavioral concerns, or other factors that may affect the student's ability to thrive within the school environment.
5. Al-Hayaat School reserves the right to merge classes based on the numbers of student's registration for JK – Grade 2.
6. Al-Hayaat School reserves the right to open and merge classes based on the numbers of student's registration for Grade 3, Grade 4 and Grade 5. The registration fee for these grades will be refunded if they are not opened this year.
7. The school Principal holds the authority to determine grade and classroom placement based on the student's academic records and evaluations.
8. Child(ren) are permitted to participate in academic assessments, competitions, and other school-related activities as determined by Al-Hayaat School.
9. All students are required to wear the official Al-Hayaat School uniform.
10. Child must possess basic motor skills, including independent movement and washroom training, prior to the enrollment.
11. Child(ren) are permitted to leave the school premises under staff supervision for approved activities such as neighborhood walks, park visits, or school trips. Parents will be kept informed ahead of the event(s).
12. If child(ren) becomes unwell during school hours, parents are responsible to arrange for their immediate pickup or transportation.
13. Should an emergency arise involving the child(ren), and the school is unable to reach the parents or the designated emergency contacts, Al-Hayaat School is authorized to take necessary actions, including contacting a physician, calling emergency services, or

transporting the child(ren) to a medical facility under staff supervision. Parents will bear full financial responsibility for any expenses incurred in such emergencies.

14. Parents/guardians are responsible for arranging transportation to and from school for their child(ren).
15. Child(ren) are permitted to be included in photographs, videos, or other media related to the school's programs or promotional activities. If parents do not wish for their child(ren) to be featured in such media, parents will provide a written notification to Al-Hayaat School.
16. Al-Hayaat School currently does not have the specialized resources or facilities to fully support students with significant learning problem, behavioral issue, or physical disabilities. Each such application will be reviewed on a case-by-case basis.
17. A positive and cooperative relationship between Al-Hayaat School, the student, and the parent(s)/guardian(s) is fundamental to the school's educational mission. Any behavior deemed detrimental to the student, other students, or the school community may result in disciplinary action, including but not limited to warnings, suspension, expulsion, or dismissal. The school reserves the right to take appropriate measures in such cases.
